## Lifetime Limited Warranty

### Warranty Coverage

Midwest Enterprises Warranties that E-Z-HydroClean Gutter Guards will be manufactured with our patented 2 stage front curve that increases the efficiency when trying to separate water from the debris with water surface tension. The factory baked-on finish will not chip, peel or blister under normal use and maintenance. This warranty is limited to the exclusions, limitations, conditions and legal rights stated in this warranty.

### Warranty does not Cover

Midwest Enterprises has no control over the installation of the product. Improper installation of the E-Z-HydroClean gutter guard systems, impact of foreign objects (including hail / ice).

Any unauthorized modifications will terminate Midwest Enterprises' responsibilities under this limited warranty.

Like all gutter protection products, E-Z-HydroClean gutter guard systems require maintenance from time to time, (especially in a sheltered roof area) like brushing off the top of the panels.

Any expense or cost incurred to clean any blockage or obstruction including those which are determined to be below grade will not be covered.

### REGISTRATION AND TRANSFER

To activate this limited warranty, the original purchaser and the installing contractor must fill out, sign and mail in the registration certificate within 30 days of the installation date.

To transfer this warranty, you must send a copy of the title transfer of the property shown on the registration certificate, and a copy of the original registration certificate within 30 days after the transfer, along with a money order or check for \$50.00 for the transfer.

### CLAIMS

To initiate a claim, you should contact the installation company for service and resolution within the warranty period and within a

reasonable period of time after the defect is discovered. There may be a service charge if the service calls are for non-warranty repair or adjustments. All other inquiries may be sent to Midwest Enterprises Customer Service Department, P.O. Box 345, St. Clair, MO. 63077. Along with a copy of your registration certificate, a description of the claimed defect and the date the defect was discovered. Midwest Enterprises will provide notification if any additional information is needed or required

### Panel Replacement

In any event and notwithstanding anything in this instrument to the contrary, manufacturer's liability under this warranty shall be discharged by supplying to the installer at no cost, a panel or panels (with the same or compatible design or color) for replacement which are proved defective under normal or proper use within the effective period of the warranty if shown to be defective by proper evidence submitted to manufacturer. We reserve the right to change or discontinue any design or color. Midwest Enterprises does not warranty and will not be responsible for any cost, defects or damage with respect to the removal or re-installation of Midwest Enterprises products or components. Midwest Enterprises have no control over panels fading.

### Exclusions, Limitations, Conditions

Manufacturer shall from time to time advise supplier/installer in writing of changes to the warranty applicable to the product.

Supplier / installer are expressly prohibited from extending any warranty on behalf of manufacturer to any person.
