Midwest Enterprises, manufacturer of gutter protection products for over 30 years, is proud to offer a 5-Year "Manufacturer's Limited Warranty" to the property owner on the registration certificate. Midwest Enterprises warrants that under normal elements of nature, sunlight, rain, snow, etc., (hail and ice excluded), and when properly maintained, the painted surface on Midwest Enterprises gutter covers will not peel, crack, chip, blister or rust for a period of five years.

Midwest Enterprises has provided this standard materials limited warranty. The Limited Warranty of performance and proper installation can only be issued by the installer. Midwest Enterprises has no control over the installation of the product. Improper installation of the E-Z Gutter Covers, impact of foreign objects (including hail and ice) or any unauthorized modification to the E-Z Gutter Cover system which adversely affects the product's performance will terminate Midwest Enterprises' responsibilities under this limited warranty. Also, like all gutter protection products, E-Z Gutter Covers require maintenance from time to time, like brushing off the top of the panels.

Manufacturers shall from time to time advise Supplier/Installer in writing of the warranty or warranties applicable to the products. Supplier/Installer is expressly prohibited from extending any warranty or warranties on behalf of Manufacturer to any person.

THERE SHALL BE NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS OR ANY OTHER OBLIGATION ON THE PART OF THE MANUFACTURER WITH RESPECT TO ANY OF THE PRODUCTS EXCEPT THE WARRANTY OR WARRANTIES EXTENDED PURSUANT TO THE SECTION. MANUFACTURER WILL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES.

In any EVENT, and notwithstanding anything in this instrument to the contrary, Manufacturer's liability under any warranty shall be discharged by supplying to the installer at no cost, a panel or panel (with the same or compatible design) for replacement of that which may prove defective under normal or proper use within the effective period of the warranty if shown to be defective by proper evidence submitted to Manufacturer. If installer is unavailable, homeowner may act as their own agent following the same requirements.

Photo and brief description of problem are also necessary.
